Gadolinium – MRI-MRA Cases Filed in Ohio

CLEVELAND, OHIO – Matthews & Associates have filed several cases so far for victims of gadolinium chelates, contrast dyes used in magnetic resonance imaging. The firm will argue in court that the makers failed to properly study and research Gadolinium and the impact it could have on those with impaired kidney function. They also failed to warn of Gadolinium’s life-altering, potentially fatal problems.

The FDA has indicated all five available Gadolinium MRI contrast agents could cause several serious problems, including nephrogenic systemic fibrosis (NSF). This potentially fatal disease has no FDA-approved cure, but diagnosis can lead to treatment options.

Brighter Days Ahead: 2008 Election Good for Citizens

Oil Rig Explosion Kills 21, Injures 63

MEXICO – Matthews & Associates are representing 28 people in a tragic oil rig explosion that killed 21 oil industry workers and injured at least 63 others.

This is a personal injury and death case involving an evacuation and subsequent explosion of an offshore platform named Usumacinta in the Bay of Campeche, Mexico. On or about October 23, 2007, a mobile platform collided with a stationary platform, damaging the stationary rig’s valve shaft, resulting in a crude oil and natural gas leak. The oil and gas leak caused the well to explode, igniting the mobile platform where a crew of approximately 85 offshore employees worked. (p. 2)

Airliner Crash Kills 153

MADRID, SPAIN – A jetliner headed to a Canary Islands vacation resort crashed during takeoff in October, turning the wooded area off the end of a runway into a nightmare scene of smoldering wreckage and charred bodies. At least 153 were believed dead, and only 19 people survived in Spain’s worst airline disaster in nearly 25 years.

\$1 Million Awarded in Motorcycle Accident

BARABOO, WIS. – Matthews and Associates’ attorney Adam Funk recovered \$1 million in Nov. 2008 for a 48-year-old Wisconsin man who was struck on his motorcycle in July last year. A motorist hit the cyclist on a country road, breaking his back, pelvis and one arm. (p. 2)

CARNEY’S POINT, NJ – A 29-year-old Maryland man was killed and three of his passengers seriously injured when an 18-wheel semi-tractor trailer veered across two lanes of traffic and crushed a 2000 Honda Accord against a retaining wall on New Jersey’s I-295 on Dec. 2, 2008. Matthews & Associates represent the man killed as well as two of the passenger survivors. (p. 2)

Bextra-Celebrex Claims Settled with Pfizer

Merck Reviewing Documents

USA – Merck Pharmaceuticals announced to the world last year that it was beginning to pay out Vioxx claims in August 2008, but only 6.3 percent of the total claims have been paid so far. More than 45,000 people have yet to be compensated as the BigPharma giant continues to review documents. (p. 3)

Bextra-Celebrex Settle

One condition of the settlement requires that each client provide records proving use of Bextra (any dosage) or Celebrex (400 milligrams) AND proof of having suffered a heart attack or ischemic stroke. Claimants who do not meet these specific gate criteria may also be compensated, at a reduced dollar amount, if they meet certain conditions. Under the terms, the defendant will NOT approve a claim for someone qualified for the Vioxx settlement.

Qualifying factors include injury (a heart attack or stroke); drug dosage; date(s) of use and date(s) of injury. Other factors include medical studies, clinical trials, and recent court rulings.

Review the information we sent in Dec. 2008, including your medical records, as this will determine your final individual settlement offer. Contact our office NOW if any of the information is NOT accurate. If it is accurate, there is nothing further you should do now.

The fair labor standards act states that "salaried" employees are entitled to be paid during plant shutdowns or "holiday" time. All salaried employees who are ready, willing and able to work but are denied access, not paid, and forced to take vacation time could be entitled to compensation. We may be able to help. 18-Wheeler Accident *(from p. 1)*

Police issued a summons for careless driving to the 66-year-old driver of the 2008 Peterbilt tractor-trailer who told them he swerved to avoid another car. The alleged other car was never identified by anyone, and the black box that many truckers now carry was erased by Carolina Tank Lines Trucking, the rig's owner. A police spokesman said toxicology reports are pending.

Dangerous Drugs

Gadolinium Dye – MRI/MRA

NSF, the disease caused by Gadolinium dye, can involve burning, itching, swelling, hardening and tightening of the skin; red or dark patches on the skin; yellow spots on the whites of the eyes; stiff joints and limbs; hip and rib pain; and/or general muscle weakness.

Trasylol

A blood-clotting agent used in heart surgeries, Trasylol can increase the risk of heart attack, kidney complications and stroke not only during surgery but up to five years after the fact.

Avandia

Avandia users are 43 percent more likely to suffer a heart attack and 67 percent more likely to die of CV causes than non-users, according to the New England Journal of Medicine. As leaders in the US with similar cases involving **Rezulin**, we handle Avandia cases.

Seroquel

Seroquel has been linked to a high incidence of type 2 diabetes, pancreatitis, hyperglycemia and other blood sugar disorders, leading the FDA to request that manufacturer AstraZeneca clearly list dangers on Seroquel packaging. We are currently litigating these cases.

Medtronic/Sprint Fidelis Leads

Medtronic has suspended sales of the Sprint Fidelis family of defibrillator leads because of potential lead fractures, reports of life-threatening complications and at least five patient deaths. Four of the Sprint Fidelis family of defibrillator leads have been recalled: models 6930, 6931, 6948 and 6949. The lead may also have been used to connect defibrillators made by Guidant, Boston Scientific and St. Jude.

FDA recommends Sprint Fidelis lead patients see their doctor, especially if experiencing multiple shocks, lightheadedness, fainting or palpitations.

Spanish Air Crash *(from p. 1)*

Of the 19 who survived the midafternoon crash of the Spanair MD-82 at Madrid's Barajas International Airport, some were in critical condition, said Development Minister Magdalena Alvarez, whose department oversees civil aviation in Spain. The airline didn't release a death toll, but said the plane carried 172 crew members and passengers, including two babies and 20 youngsters.

Spanair, a Spanish company owned by Scandinavian Airlines, said it did not know what caused the accident. The jet veered hard right just as it got airborne, then crashed and broke into pieces.

Rig Explosion *(from p. 1)*

Besides the 21 confirmed dead, one person is still unaccounted for and presumed dead. Matthews & Associates have filed two separate motions to intervene and be added to the original petition filed by Hubert Oxford in Beaumont, Texas. Motions were filed in U.S. District Court, Eastern District of Texas, Lufkin Division. The law firm represents both injured survivors and family members of the deceased.

Motorcycle Crash *(from p. 1)*

Surgeons inserted a metal rod into the man's back and also fused vertebrae T6 – T11. The resulting injuries robbed the man of the ability to walk without the aid of a walker. He also suffers mid-body numbness and lower extremity weakness.

Fen-Phen Valve Surgery can Increase Benefits

Fen-Phen clients who have open heart surgery to repair or replace mitral or aortic heart valves may have additional benefits worth thousands of dollars. Contact Matthews & Associates if this situation applies in your case.

In case of death, a client's family could receive even more compensation if the death is heart-valve related. These benefits for the opt-out clients who filed law suits are available until March 31, 2010.

Mesothelioma/Asbestos

Matthews & Associates continue to pursue mesothelioma cases throughout the country. Mesothelioma is caused by exposure to asbestos, which is present in many work places such as construction, ship building, automotive and other manufacturing industries. People with a history of extended asbestos exposure are at the highest risk for developing malignant mesothelioma.

Even minor exposure to cancer-causing asbestos can result in malignant mesothelioma. However, mesothelioma has a latency of up to 40 years. Many people previously exposed to asbestos are only now showing symptoms; the average age of meso victims is 50 – 70.

Asbestos consists of tiny fibers that can find their way to the outside lining of the lung and damage the cells pleura is made of. These fibers can also be carried on clothing, which also makes them dangerous to family members.

Symptoms may include, but are not limited to, respiratory distress and a lasting cough and pneumonia. Symptoms are often mistaken for less serious ailments, and many patients show no signs at all. Diagnosis is usually made by chest x-rays and CT scans. Anyone with concerns should seek medical help.

Vioxx Settlement Status *(from p. 1)*

As of the last status conference before Judge Eldon Fallon on Nov. 21, 2008, the Vioxx Fund Administrator had received more than 48,316 enrollment packages to review and was behind in the review process. To date, only 3,055 of the 48,316 claimants nationwide (6.3%) have received Interim Payment benefits. None of these benefits have been paid to any of our firm's claimants.

The Claims Administrator and Merck underestimated the amount of time to receive, process, and review all Claims Packages and Pharmacy, Medical, and Event ("PME") records. The Claims Administrator posts any review results and any deficiencies on a Vioxx portal which our law firm monitors daily. We expect the Fund Administrator will not complete claim reviews until late 2009, with the Interim Payments for our Claimants pushed back to Spring 2009 at the earliest, and the final disbursement of settlement funds to be late 2009 at the *earliest*. We will notify each claimant immediately when we receive the claimant's review notification on the Vioxx portal.

No one can tell you at this time the amount that you (or anyone else) will receive under the Settlement Program. The settlement fund for the Claims Administrator cannot determine the value of any claim until he reviews all claims packages from all the people in the United States who accepted the settlement. Before the Claims Administrator can calculate your case's value (or any other case), he must know each claimant's injury type, injury level, duration of Vioxx use; and other factors that affect claim values. Because of the thousands of cases the Claims Administrator must review, the claims process could take one to two years from the deadline, which was Nov. 30, 2008, to submit the claims packages.
